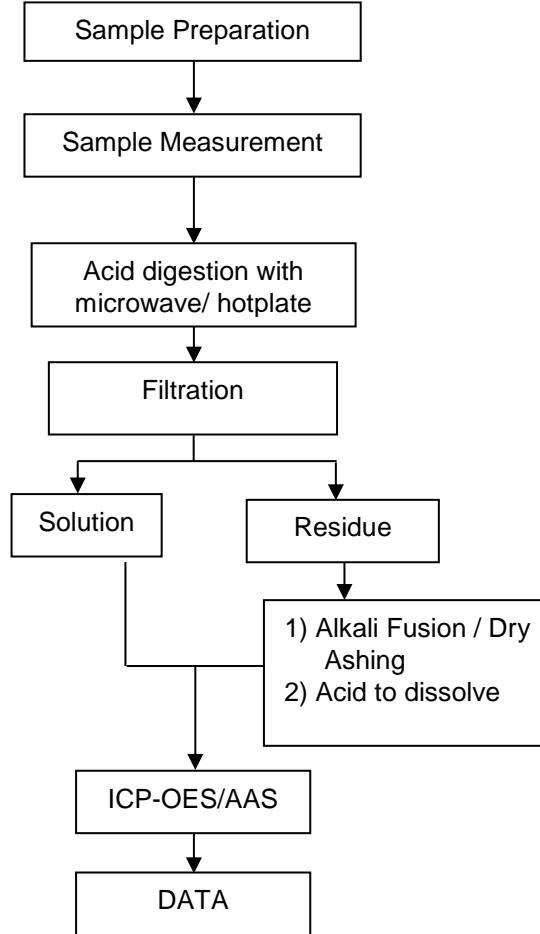

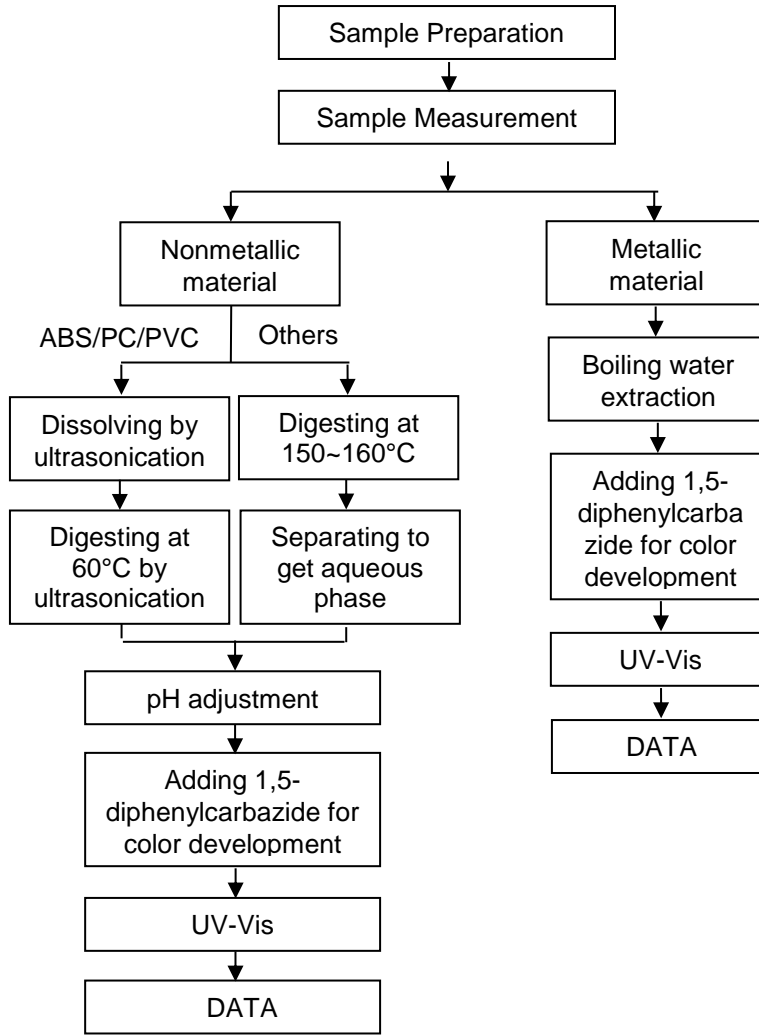

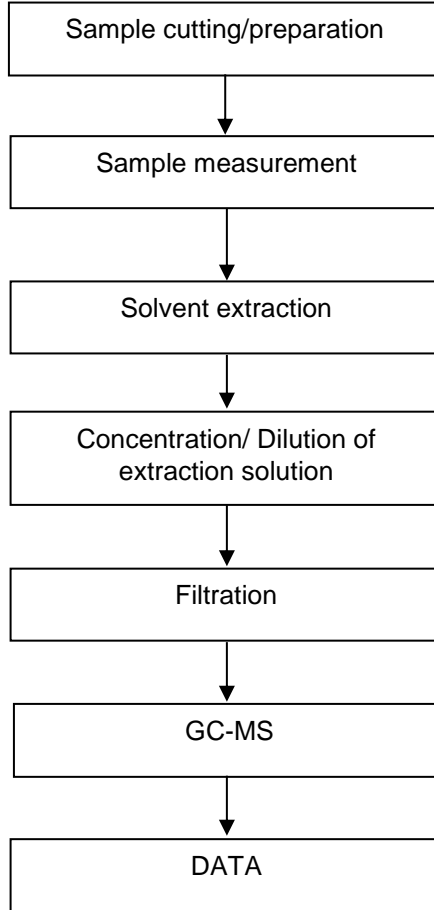

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**

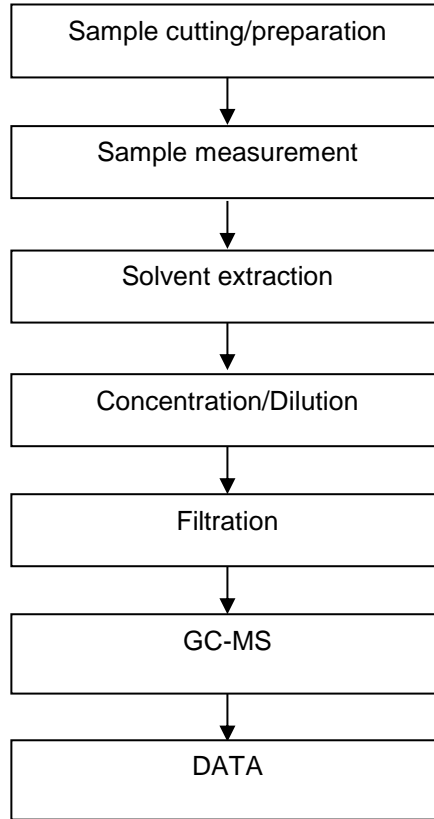


### PBBs/PBDEs Testing Flow Chart

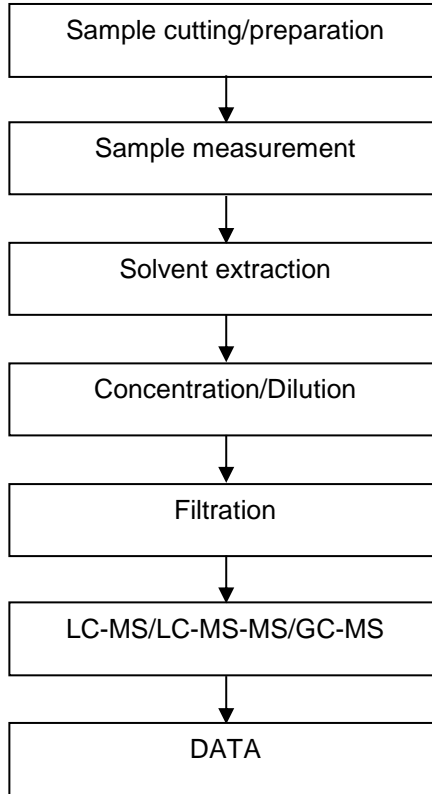




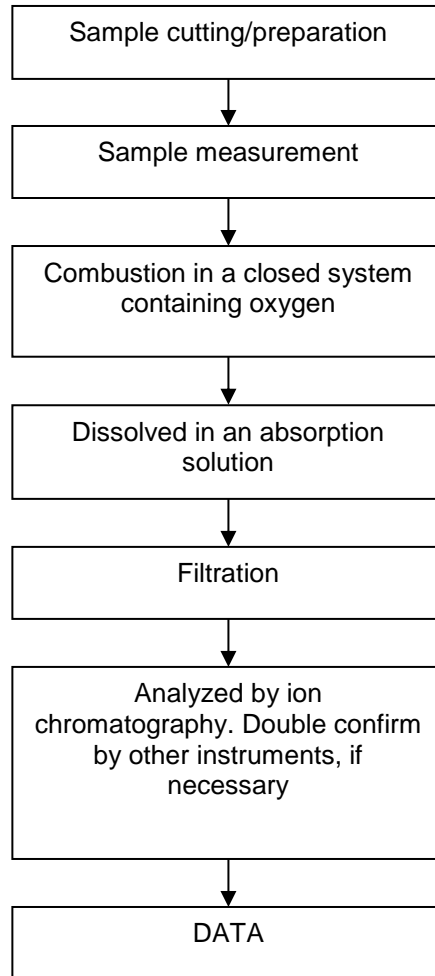
### Phthalates Testing Flow Chart



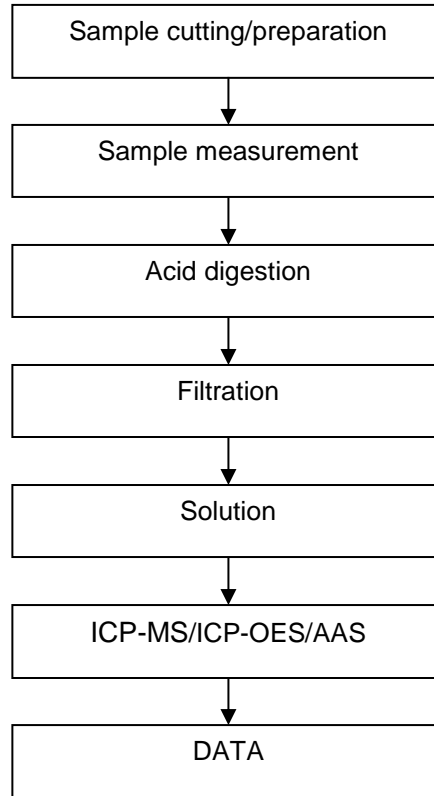
### PFASs/ PFOS/PFOA Testing Flow Chart
