

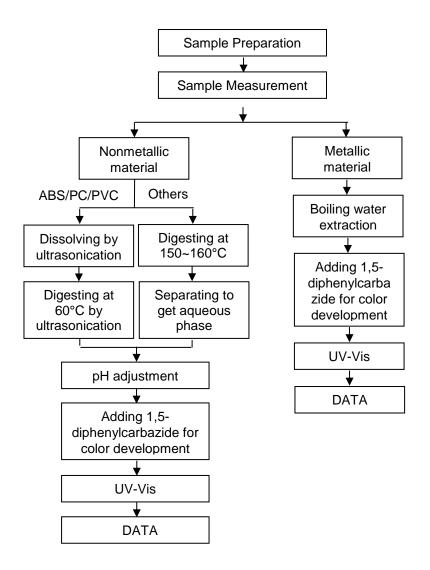



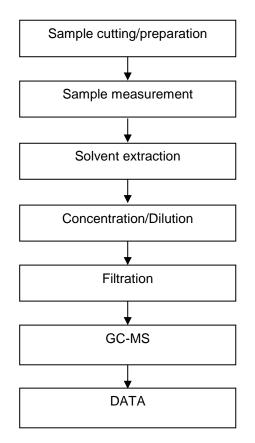



Halogen Testing Flow Chart





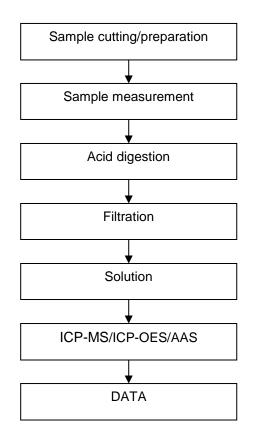

Elements Testing Flow Chart


