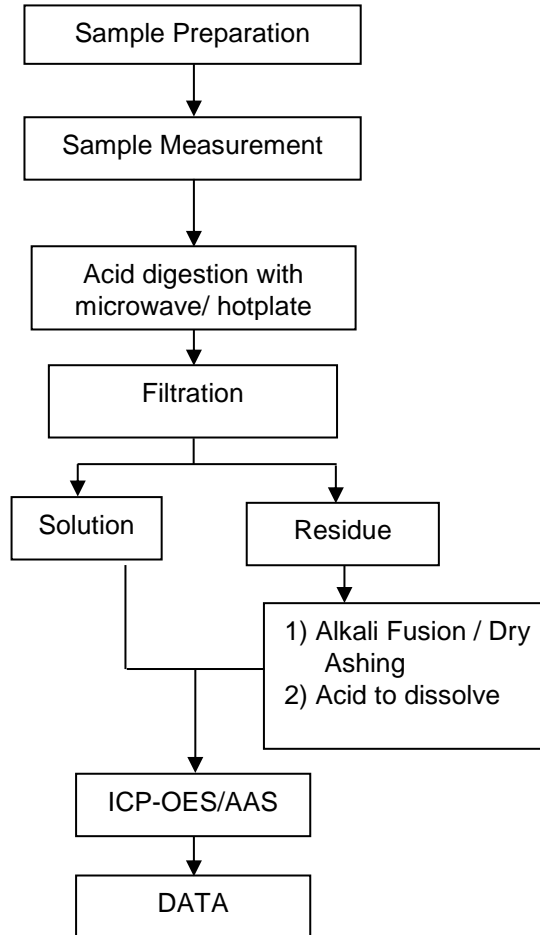

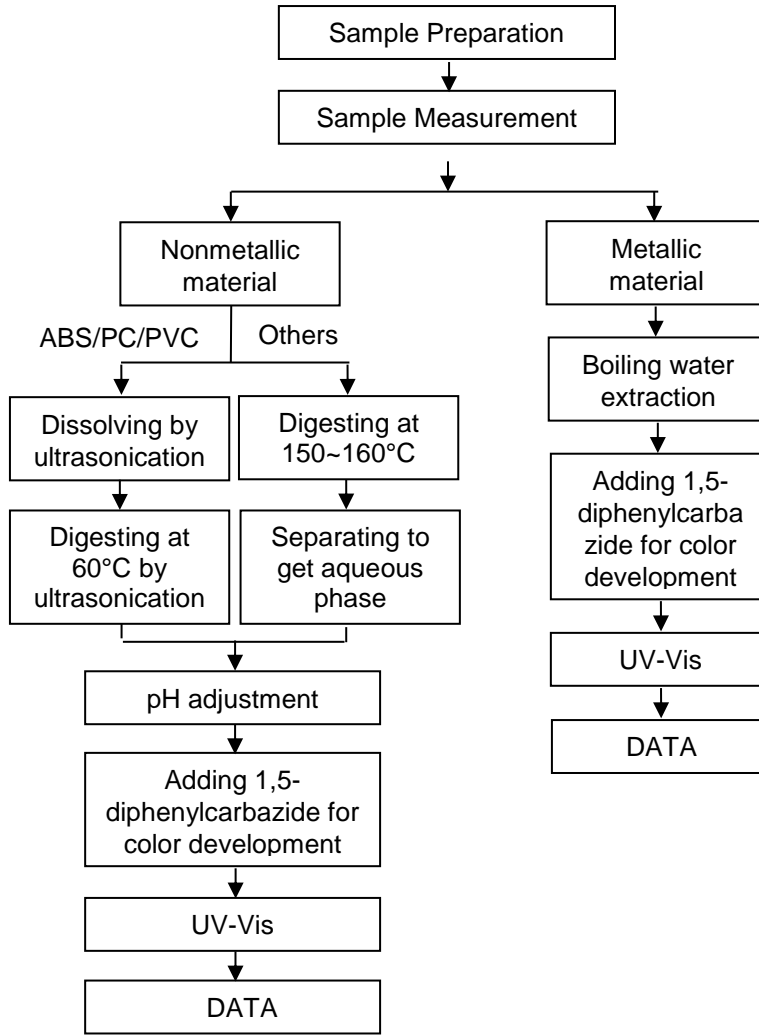

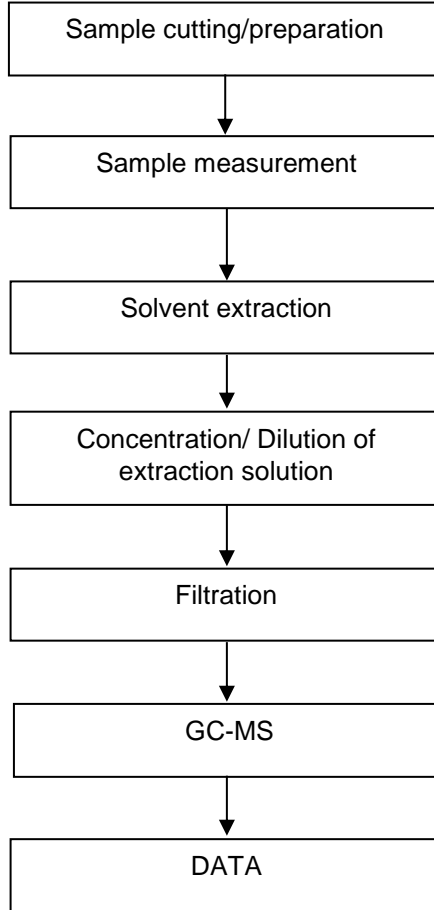

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**

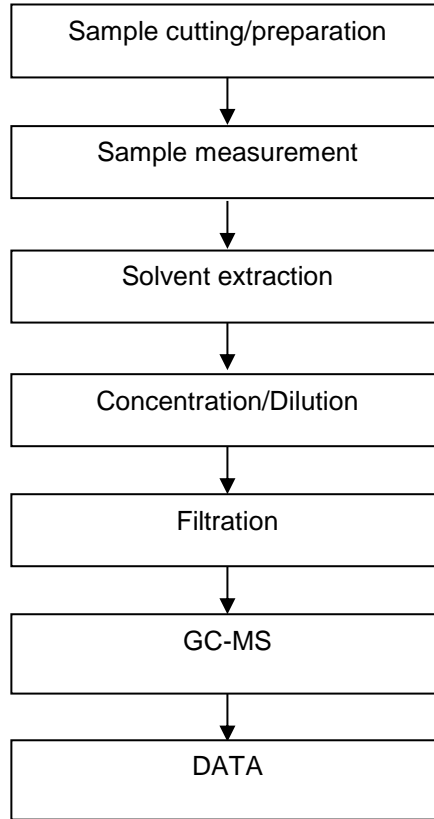


**PBBs/PBDEs Testing Flow Chart**



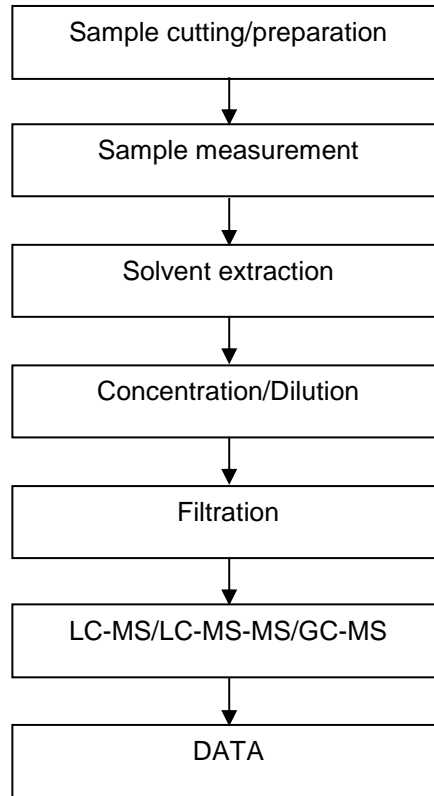


### Phthalates Testing Flow Chart



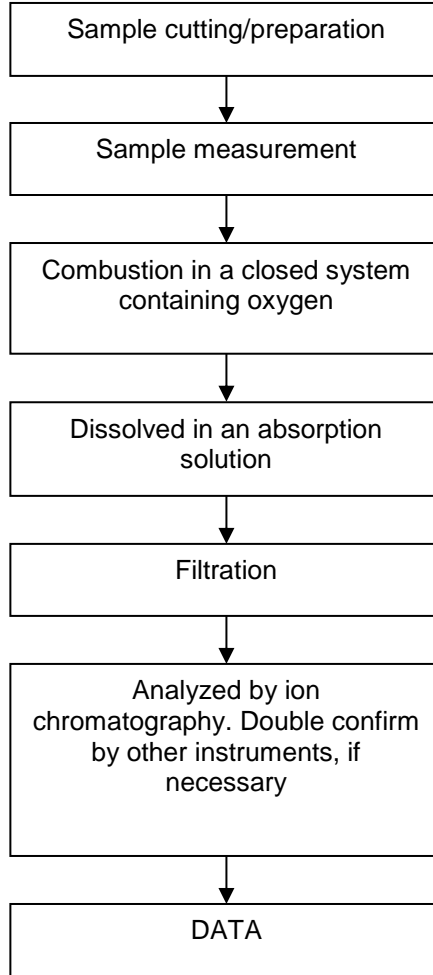

### PFASs/ PFOS/PFOA Testing Flow Chart



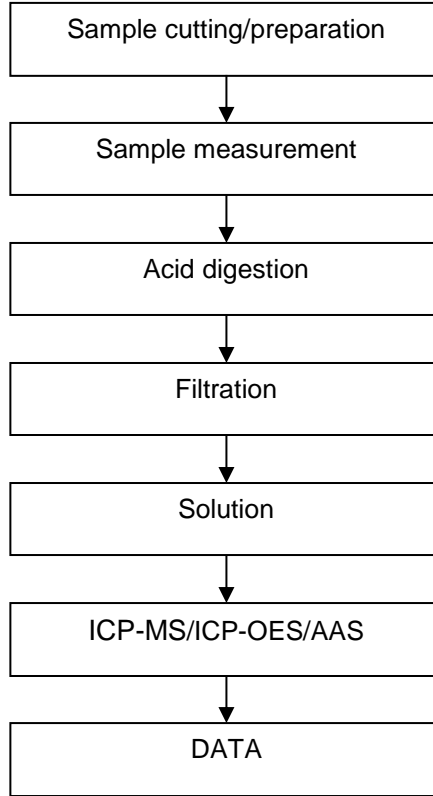

**Halogen Testing Flow Chart**

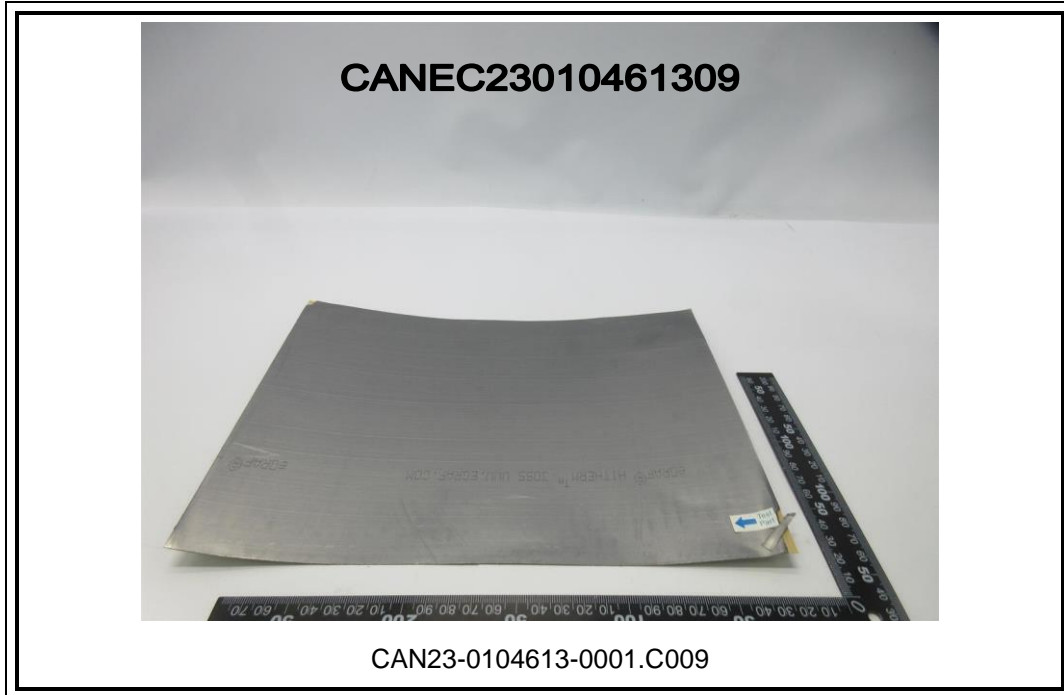
